

State of Colorado – Voter Registration Application Form

YOU CAN USE THIS FORM TO:

- Register to vote in Colorado
- Change your name and/or address, if there is a change since you last voted
- Declare a party affiliation, or change party affiliation

TO REGISTER YOU MUST:

- Be a U.S. Citizen
- Be 18 years of age
(Note: You must be 18 years old on or before the date of the general, primary or other election in which you want to vote.)
- Reside in this state and at your present address at least 30 days before an election
- Important: You must include your complete address with apartment number or unit number to ensure your registration confirmation and to receive important mailings.

DEADLINE INFORMATION:

If you want to vote in an election, you must mail or deliver this form to your county clerk and recorder no later than 29 days before the election in which you want to vote. Your eligibility to vote will be based on the post-mark date or the date you file this form in the county clerk and recorder's office.

FIRST TIME VOTERS WHO REGISTER BY MAIL

If you are registering to vote for the first time in the state of Colorado **and** are mailing this registration application, a **copy** of one of the following forms of identification information is required to be submitted **with** the mail-in registration form:

- A valid Colorado driver's license; or
- A valid Colorado Department of Revenue identification card; or
- A valid U.S. passport; or
- A valid pilot's license with photograph issued by the Federal Aviation Administration; or
- A valid employee identification with a photograph issued by the U.S. Government, Colorado state government, or any county, municipality, board, authority, or other political subdivision of the state; or
- A valid U.S. Military Identification card with photograph; or
- A copy of a current utility bill, bank statement, government check, paycheck, or other governmental document that shows the name and address of the elector; or
- At least the last four digits of the person's social security number.

If the approved form of identification shows an address, it must show your address as being in the state of Colorado.

Do not include original documents with this application.

IF YOU DO NOT SUBMIT PROOF OF IDENTIFICATION WITH YOUR MAIL-IN REGISTRATION FORM, YOU WILL BE REQUIRED TO PROVIDE PROOF OF IDENTIFICATION USING THE TYPES OF IDENTIFICATION DESCRIBED ABOVE AT THE TIME OF VOTING.

You can get registration application forms at most state agency offices, public libraries or at any county clerk and recorder's office.
